



**Delaware State Golf Association**  
**2011 Junior Amateur Championship**  
 Wednesday, June 29 & 30, 2011  
 Newark Country Club, Newark, Delaware



**TOURNAMENT FORMAT:** The Junior Amateur Championship is a 36-hole, individual stroke play competition within age classes.

**ENTRY PROCEDURE:**

1. All entries must be submitted on the official entry form. Additional entry forms may be obtained at [www.dsga.org](http://www.dsga.org), at host clubs, or by calling the Delaware State Golf Association at 7234 Lancaster Pike - Suite 302-B, Hockessin, DE 19707. (302) 234-3365. Late, incomplete or inaccurate entry forms will not be accepted.
2. All entries and entry fees of \$35.00 must be received at the DSGA office by 5:00 P.M. Monday, June 19th, 2011.
3. If an entrant withdraws on or before the entry closing date, the full entry fee will be refunded automatically. If a player withdraws after the entry closing date, **no refunds** will be given. If you cannot compete and do not officially withdraw prior to the tournament, you will be treated as a "no-show" and will be subject to exclusion from future DSGA sponsored events.
4. The entry fee of \$35.00 (Check or Money Order, payable to Delaware State Golf Association), must accompany each entry. Entry fee includes lunch for participants ONLY on both days.

**ELIGIBILITY:** This Championship is open to male amateur golfers who are at least 12 years old\*, who have not reached their 19th birthday as of June 29, 2011 and are not currently attending college. Players must be either a member of a DSGA member clubs or a resident of the State of Delaware.

\* **Under 12 years old:** Consideration will be given for contestants under 12 years old. For consideration, players must have a reasonable understanding of the rules, golf course etiquette, must be able to carry a bag of clubs for 18 holes while maintaining the pace of play and must be authorized and approved by the DSGA.

**STARTING TIMES:** Tee times will be assigned for Wednesday, with a shotgun start on Thursday, followed by an awards luncheon for the contestants.

**CADDIE POLICY:** Caddies are **NOT** permitted. Players must carry their own clubs. Players are not permitted to use golf cars, but may use pull carts.

**CONDUCT CODE:** The following actions will be considered violations of the Conduct Code: any abusive language, club throwing, cheating, disrespect of volunteers or officials, abuse of the course, leaving the course during your competitive round without permission from a DSGA official, any use of or association with drugs or alcohol, not adhering to the dress code during any portion of the tournament, or other conduct not becoming of a DSGA Junior competitor. Conduct Code violations may result in any or all of the following: a warning, disqualification from the tournament, or indefinite suspension from DSGA events.

**DRESS CODE:** Appropriate golf attire is required during any portion of the Championship, including the awards luncheon. Players will wear Golf slacks or golf / Bermuda style shorts during all rounds of the championship. Shirts with a collar are required at all times while at the golf course.

**RULES OF PLAY:** The USGA Rules of Golf, modified by local rules established by the DSGA, will be used. The DSGA reserves the right to alter any of the conditions of competition, schedule and tournament format at its discretion. The decisions of the DSGA, in any matter, will be final.

**SPECTATORS:** Spectators are permitted, however they are not permitted to walk within 30 yards or offer advice to the competitors. Spectators who are observed "participating" will be asked to leave the golf course. **Golf carts for spectators will not be permitted under any circumstances. Please be respectful of the competitors, it is their tournament let them play it!**

**AWARDS LUNCHEON:** Immediately following play on June 30th, all contestants are invited to attend a complimentary Awards Luncheon as a guest of the DSGA. All contestants will be seated together. Parents and guests are also invited to attend the Awards Luncheon. (Guest fees and details for the Awards luncheon will be sent to contestants after entry is received)

**PRACTICE ROUND:** (Details for a practice round will be sent to contestants after entry is received)

**ENTRY DEADLINE: Entry must be received at the DSGA office by 5:00 PM on June 19<sup>th</sup>, 2011**
